CFSEK Receives Estate Gift

The CFSEK received a gift of \$552,419.52 on Friday, November 13th from the Rosalie D. Manley Trust. It marks the largest estate gift left to the CFSEK to date.

Manley, of Pittsburg, named the CFSEK as the Remainder Beneficiary of her estate for the purpose of creating an Unrestricted endowment at the CFSEK. "She had

many charitable uses in mind," said Bill Morin, Manley's estate attorney, "but she wasn't sure what charity she wanted to give to. That's when we started talking about the Community Foundation." Annual allocations from the endowed fund will be used to make grants in Manley's name during the CFSEK's annual competitive grant cycle.

"The CFSEK is honored and humbled to receive this gift from Mrs. Manley," said CFSEK Executive Director Kim Clark. "We are always pleased to help local citizens with their charitable goals, and gifts such as these allow the CFSEK to make an impact on the changing needs of our citizens through strategic grantmaking."

The gift was a result of the Manley Estate that was managed by Commerce Trust Company, of Pittsburg, an affiliate of Commerce Bank N.A. "Because of Rosalie's caring concern for the welfare of her community, she is leaving this legacy that will benefit future generations and honor her memory for many years," said Gay Adams of Commerce Trust Company.

Manley was born in Pittsburg in 1928, and she graduated from Pittsburg High School in 1946. Rosalie was a member of the Telephone Pioneers Club serving as President and Past President, AARP, and Western Resources Retirees Club.

CFSEK Selected to Participate in Grow II

The Kansas Health Foundation recently announced that it has selected the first round of community foundations to participate in the second chapter of the Giving Resources to Our World Healthy Kansas Initiative (GROW II). GROW II is focused on strengthening the community foundation field in Kansas and building endowments to underwrite solutions to local health issues. The CFSEK is one of twelve community foundations selected to participate.

“We know that many Kansans care deeply about their communities and if there was an opportunity for them to give back, they would. GROW II is building the infrastructure to make that possible,” says Steve Coen, president and CEO of the Kansas Health Foundation. The selected community foundations will be challenged to raise endowment dollars which will be matched by the Foundation. If these GROW II communities are successful in their fundraising efforts, over \$16 million will be raised for the betterment of communities across Kansas. The CFSEK is eligible to generate up to \$1.2 million for the benefit southeast Kansas.

The following is a list of the community foundations selected to participate in this first round of GROW II in addition to the matching endowed grant amount they are eligible to receive from the Kansas Health Foundation.

- Central Kansas Community Foundation (\$600,000) — serving Harvey, Marion and McPherson counties
- Community Foundation for Cloud County (\$300,000)
- Community Foundation of Dickinson County (\$500,000)
- Community Foundation of Southeast Kansas (\$600,000) — serving Bourbon, Cherokee, Crawford and Labette counties
- Douglas County Community Foundation (\$600,000)
- Greater Salina Community Foundation (\$800,000)
- Golden Belt Community Foundation (\$500,000) — serving Barton, Pawnee, Rush and Stafford counties
- Heartland Community Foundation (\$500,000) — serving Ellis, Rooks and Trego counties
- Hillsboro Community Foundation (\$300,000)
- Republic County Community Foundation (\$300,000)
- Russell County Area Community Foundation (\$300,000)
- Smith County Community Foundation (\$300,000)

In addition to the matching endowed grants, each of the above community foundations will receive training, one-on-one consulting and support and, if they meet certain benchmarks, an operating grant of 3.5 percent of the matching grant awarded by the Foundation on an annual basis for six years.

The Kansas Health Foundation started working with community foundations across Kansas in the late 1990s as a way to further its mission of improving the health of all Kansans. The Foundation believes that strong community foundations build healthier communities.
