

### **Community Foundation Hosts Community Conversations**



As a part of the general grant cycle for 2012, the Community Foundation of Southeast Kansas hosted community conversations in each of the four counties that we serve. These conversations serve as a vehicle to learn about the concerns of the area's front line providers. CFSEK staff attended the local county coalition meetings to have an open dialog with providers who work with people in need of services every day. These providers are asked about the specific needs in their county. Conversation topics can range from childhood obesity, assistance for the working poor, food scarcity, youth mentoring to poverty education. CFSEK staff and grant committee met to review the information and determine the areas of focus for 2012 general grant cycle. The focus areas for this grant season are **BASIC HU-**

**MAN NEEDS** and **YOUTH ACTIVITIES**. In Pittsburg only, an additional focus is arts and culture. CFSEK looks forward to working with local non-profits to impact the needs of our region.





### Girard Area Community Foundation receives \$300,000 Kansas Health Foundation GROW grant

The Girard Area Community Foundation has been awarded a \$300,000 grant through the Kansas Health Foundation's GROW Healthy Kansas community foundation initiative. The Girard Area Community Foundation is one of 14 community foundations in the state to receive this funding, and is one of 39 total community foundations in Kansas involved with the GROW II program.

The GROW (Giving Resources to Our World) Healthy Kansas community foundation initiative was launched in 1999 as a 10-year grant of the Kansas Health Foundation, with the goal of starting and strengthening community foundations in Kansas. The intent was to work with community foundations to help build local philanthropic leadership and resources that would result in long-term, sustained health improvements in communities throughout the state. At the end of the first decade of the program, the collective resources of GROW community foundations had grown from \$19 million to \$95 million by the end of 2009.

"Community foundations play a vital role in the strength and growth of a community or region," said Steve Coen, president and CEO of the Kansas Health Foundation. "Through this initiative, the Kansas Health Foundation looks to help community foundations build their capacity and resources in order to make a positive impact on their communities for generations to come."

Improving health and quality of life are goals that fit well with the Girard Area Community Foundation's efforts to empower people to give back to their community and support growth by providing financial support to area schools, libraries, youth programs, parks, and other community projects.

The goals of the Girard Area Community Foundation are to encourage private giving for public good, build endowments for community needs, and assist donors who seek to strengthen our communities now and for future generations. Individuals, families, businesses, and organizations may all create charitable funds or contribute to the Girard Area Community Foundation.

# Fort Scott Area Community Foundation Awards a "Surprise Grant"

The Fort Scott Area Community Foundation recognized a need in the community with a Surprise Grant on April 26, 2012. *Lee's Paws and Claws Animal Shelter* was awarded a \$600 grant.

Fort Scott's newest animal shelter was built in October and is located at 721 240th St., right outside Fort Scott, KS. An anonymous donor matched up to \$2,000 for all funds the animal shelter raised during the month of April. As a result of the matching funds, the \$600 FSACF grant grew to \$1200 for the shelter.

*Lee's Paws and Claws*, named for donor Lee Weast, is now built and paid for. It is associated with the Shirley Yeager Animal Friends Foundation, a fund at the Community Foundation of SEK.

Since, since only the annual interest from that endowed fund may be used to pay ongoing expenses, the shelter is currently in need of contributions to help with operating expenses. FSACF was happy to lend a hand!
