

A STRONG FOUNDATION A LASTING LEGACY

The men and women who accepted the challenge to create and operate the Pittsburg Area Community Foundation did so because they love Pittsburg and Crawford County as a place of heart. We selected strong community leaders to form the Foundation Board of Trustees and staff its committees. Quickly, we met the challenge of the Kansas Health Foundation to raise \$300,000 for operating funds and received their match of \$300,000 for the same purpose. As we worked to meet the second challenge grant of \$250,000, we raised more than \$500,000 in that effort. Today, the Foundation has a little more than \$2,000,000 in its funds and an excellent staff. We have a goal of raising \$7,000,000 by the end of 2007. We have accepted our third challenge grant program from the Kansas Health Foundation that will begin in January of 2005 and go for two years. Clearly, the Foundation and its trustees have acted on their vision and will soon have a fully viable Foundation in place for the needs of the people who live in Pittsburg and Crawford County.

☆☆☆ 2004 PACF Grant Recipients ☆☆☆

<u>Backpack Buddies \$1,000</u> To purchase single serving, nonperishable food to send home with children over the weekend so they can come to school on Monday, ready to learn.

Catholic Charities \$2,500 To be used to purchase materials and to provide parenting classes at no charge for three, 8-week classes. Additional grant dollars will be used for gas vouchers to assist parents in getting their children to medical appointments.

<u>Community Health \$2,275</u> To purchase a spirometer for our pediatric clinic. This piece of equipment aids in the diagnosis of asthma and other respiratory illnesses.

<u>Family Resource Center \$2,500</u> To purchase replacement items such as high-chairs, and baby swings. No new dollars have been available since 1997 for replacement of equipment.

<u>McCune Playground \$2,300</u> To purchase safe playground equipment and repair see- saw and slide. No playground equipment currently available for children age two to five.

Mother to Mother Ministry \$350 Transportation and food for 25 mothers and children to go to George Washington Carver Monument. Introduction to a man who struggled and won. Many of our mothers need encouragement and positive role models like Carver.

New Hope \$1,000 To pay for sporting events and sporting activities through Special Olympics for adults and children with mental retardation

PACO \$1,000 To support a domestic violence program that is bi-lingual and culturally appropriate for the Hispanic population.

<u>Restorative Justice Authority \$1,000</u> To provide transportation for youth in State's custody from their current placement, back to the home in Crawford County. To assist the youth in successful reunification with their parents or caregiver through home passes.

<u>Wesley House \$2,500</u> To provide additional food to needy families with children during June, July, and August, 2005. The monthly increase for food during the summer months when children are not in school was 37.5% in 2004.

<u>Kids Voting Kansas \$3,500</u> To provide support to all Crawford County schools as they implement the "Kids Voting Kansas" curriculum.

Looking toward the future, with a vision for helping animals, the Friends are committed to providing a permanent fund to help the Ft. Scott Animal Shelter."

"By investing with the PACF," Chris Ward, PACF Executive Director, stated "only the interest, not principal will be granted allowing the fund to grow. By establishing this endowment with a Foundation holding a 501 (c) (3), this fund can accept additional donations that will be tax deductible to the donor, and at the same time grow the principal, which in turn will increase the grants."
